

“Meet Natasha” Burnout Contest sponsored by Gwee Gym, LLC is open to legal residents of the Continental U.S. (excluding Alaska and Hawaii), who are at least 18 years old at the time of entry. Void where prohibited. Submission period opens April 17, 2017 at 12:00 a.m. PT and closes May 7, 2017 at 11:59 p.m. PT. For full details, please see the Official Rules by clicking [here](#).

All prize values are in US dollars, and cash prizes will be awarded in US dollars.

1. Who Can Enter?

This Contest is open to legal residents of the continental United States (excluding Hawaii, Alaska, Puerto Rico, territories of Guam, the Virgin Islands and American Samoa) who are at least 18 years of age at the time of entry.

2. Contest Description

“Meet Natasha” Burnout Contest sponsored by Gwee Gym, LLC is an eight-week challenge beginning May 8, 2017 and ending July 2, 2017.

Contestants must commit to working out with the Gwee Gym Pro following all Burnout program requirements for eight weeks during the contest timeframe. The Burnout program includes, but is not limited to, six workouts per week and following the provided Healthy Eating Guide.

Contestants must submit “before” photos and measurements upon registering for the challenge. Contestants must then submit “during” photos and measurements four weeks into the challenge. Contestants must submit their “final” photos and measurements at the end of the eight-week challenge. “Before” photos and measurements must be submitted before May 7 2017, “During” photos and measurements must be submitted by June 12, 2017, and final, “after” photos and measurements must be submitted by July 8, 2017.

Upon completion of the contest, contestants must submit a minimum of 500-word essay on their transformation story and how the Gwee Gym Pro and Burnout Program helped them achieve their success.

At the end of the eight-week contest period, three winners will be selected to receive a \$500 cash prize and an all-expense paid trip to meet Natasha Hastings (date & location TBD) for one person. “All-expense paid” means a round trip plane ticket from the closest major airport, one night stay accommodations in a hotel and a stipend (TBD) for transportation costs and food. Winners will meet Natasha Hastings during a “Tea Time” filming session, share their transformational testimonial and participate in a photo/video shoot for potential Gwee Gym/ Burnout commercials.

3. Submission Requirements

Directions to Enter Contest

- b) Register for the contest at Burnout.fit/challenge supplying all following information when prompted: Name, Age, Address, Phone Number, Email, Height, Physical Measurements, “Before” Images, Paragraph answering: What does your current fitness/diet routine look like & what are your weight loss and fitness goals?
 - c) Join FB Group “Burnout Challenge - Meet Natasha Hastings!” to stay engaged during the contest period.

Contestants must submit their entries at Burnout.fit/challenge between April 17, 2017 and May 7, 2017. Late, incomplete, or otherwise non-conforming entries will be disqualified in Gwee Gym’s sole and absolute discretion.

4. Selecting Grand Prize Winners

To be eligible to win, Contestants must have fulfilled all above requirements. Final photos and measurements must be submitted by July 8, 2017.

All final entries will then be reviewed by a panel of judges and finalist will be chosen. Judging will be based on criteria including but not limited to, (1) the overall transformation of each Contestant's appearance, judged both from the original "before", “during” and "after" photographs, (2) The overall healthiest transformation result as evidenced by statistical changes (weight loss, muscle gain, measurements), (3) The originality, creativity, expressiveness, and compelling nature of the Contestant's essay of their transformation process, and how the process has impacted their life.

Once finalists are chosen, they will be notified by email and/or phone by the contact information provided in their submission. Finalists will then be interviewed and screened to verify information and confirm availability for time frame (TBD) to meet Natasha Hastings.

Three (3) Grand prize winners will then be selected based on all above criteria and results.
